## CALL FOR ENTRIES

### 1. CONCEPT

Der Verzicht. Powerlessness: take a step backwards. Take a step aside when facing the unknown, something too big to deal with, too difficult, too much. In defense of giving up. In praise of vulnerability. Failure counts. Against careerism, and presumption. Against conflict, instinct, and rivalry. Substance breaks down, something else is done. Power-lessness, so that the Act differs from the answer.

### 2. REQUIREMENTS AND HOW TO PARTICIPATE

Participation is free and open to professional or emerging photographers, enthusiasts, self-taught photographers over the age of 18. The authors will be able to compete individually or collectively and will be able to choose the method, style and form most suited to their way of expressing themselves

To participate in the selection, the candidate must send:

. a photographic project on the given theme, Verzicht, consisting of max 10 images (JPEG format, 1500 long side 72 dpi)

- . a descriptive text of the project of max 500 characters in PDF format
- . a short biography in PDF format
- . the registration form complete with all the data (Attachment n.1)
- . self-certification in PDF format (Attachment n. 2)

Projects that do not comply with the specifications indicated will automatically be excluded from the selection.

### 3. PROJECTS SUBMISSION

The application, complete with all the required materials, must be received in a single compressed file called Verzicht\_NameSurname, with the subject CALL OFF CIRCUIT NAME AND SURNAME no later than 00.00 on 5th May 2024 to the e-mail address grenze.arsenali.fotografici@gmail.com.

N.B.: in the case of files larger than 10 MB, use upload clients such as WeTransfer, Filemail etc.

### 4. CANDIDATES SELECTION

The finalists will be contacted via e-mail by the organizers by the end of May to agree on the details relating to their photographic project, the print support, the dimensions of the works and any other expedients, in consideration of the set-up plan and the needs that the exhibition space requires. In fact, the works will be exhibited outdoors and therefore will be presented on synthetic print media (e.g. pvc, forex, flag cloth, etc.).

The authors of the selected projects will be asked to send the materials by and no later than 30th June 2024.

The costs of printing, shipping and collection of the works are responsibility of the authors.

The selected projects will then be communicated on the social channels and on the website of Grenze Arsenali Fotografici, and on the platforms of the Amici del Lazzaretto di Verona Cultural Association.

N.B.: We decline all responsibility in the event of damage to the photographic works during shipment.

### 5. SET-UP AND DISMANTLING

The photographic projects will be exhibited in an open-air setting at the Lazzaretto in Verona in conjunction with the main circuit with a schedule that will be defined in a second phase.

During the preparation, the presence of the authors is appreciated for the arrangement of the works.

To ensure the integrity of the projects, the exhibition space will be equipped with a custody service at the expense of the organization, however we decline all responsibility for any damage or theft within the area.

At the end of the exhibition, the authors will have to arrange for picking up the works at their own expense, no later than 30th September 2024. If the author is unable to collect them by that date or in the event of any problems, special arrangements will be made with the organizers.

# INFORMATION PURSUANT TO D. LGS. 196/2003 ON THE TREATMENT OF PERSONAL DATA

We inform you that in compliance with Legislative Decree 30 June 2003 n. 196, the personal data provided by the participants when completing the registration form, collected and processed with IT tools, will be used to identify the authors of the photographs on the various occasions in which they will be exhibited or published and for communications relating to the competition itself.
